Society Ethics Process Management Project Update

Project started to address three issues: the current code of ethics, the committee membership (the contents and criteria of that membership, and the ethics committee's roles and responsibilities.

Code Ethics - we established a definition of an ethics violation

Violation definitions: Fraud, conflict of interest, discrimination, embezzlement, gender or sexual based violence or harassment, retaliation or retribution, sabotage or vandalism, safety, suspicious activity, woeful misconduct.

Committee Membership - we want to have a committee with, both, expertise and diversity. To aid in this, the nominating committee will take over the selection of the candidates for the ethics committee. Ethics Committee Roles/Responsibilities - we are addressing opportunities to respond more timely and effectively to reports that come in.

Motion made and passed to endorse the anonymous ethics reporting hotline project.

Board Operations Manual Project Rewrite Update

This manual was initially named Board Policy Manual and has not undergone a redline editing process since 2017. A week prior, the board was provided with a preliminary draft of the manual with more work to be done.

Final draft is still intended to be presented to the board by the end of this calendar year (2023).

#### **Performance Reports**

State of the Society Marty Monson

Q1 Business results and updates through May

- Erik Dove
- \$80,000 positive variance of year to date loss (\$32,000 less than 2022)
- Conclusion of litigation expenses at the close of Q1 with a few lingering expenses.
- May financials
  - We continue to make up additional space in our budget and this trend is ongoing.
- Financial Forecast cash flow perspective
  - To date through May 2023:

- Marketplace sales continue to trend above plan.
  - April 1st marks price increase on sheet music sales.
- Discontinuing physical marketplace sales in Nashville and looking into implementing a virtual print on demand marketplace launched in Q3.
   This will be branded with Districts and local chapters to provide barbershop-related merchandise to our members.
- Conversion from Eezy dues to our regular monthly dues model.
  - Discount provided to make up for the dues prepaid from members who chose to pay for the full year upfront. This expired at the end of April 2023.
  - Approx. 2500 members had taken advantage of this temporary discount and are now on the new monthly dues model resulting in increased revenues.

#### At Risk Items

- International Registrations
  - Registrations are below plan, but several expense cuts in other areas are currently being negotiated to help offset this registration decrease.
- Harmony University
  - Registrations are below plan, as well. But, similarly to International solutioning, expense cuts are being put in place to offset.
- Rising Interest Rate Market
  - Impact on our interest expense on usage of our line of credit.
  - Loan/mortgage on building is a fixed rate, so the interest rate has no impact there.
- Cash Flow Activity
  - \$100,000 draw from line of credit in 2023
  - Anticipating as much as \$300,000 to be drawn by July due to above expenses.
- 2022 Audit and 990
  - BHS audit component is completed and we are paused for HFI component, which is expected to be completed within the next month or two. 990 will be dependent on this component completion.
    - IRS extension approved extending to 6 months.
- 2024+2 Business Plan & Budget Process and Approval Timing
  - CEO Statistics Dashboard
    - Growth rate, from COVID, of membership, quartets, choruses, etc.
      - Membership Growth started, May 2021, at 12,600 to May 2023, nearly 14,000 members. We haven't seen this kind of growth since the 80's.
- DEI Assessment Wrap Up and Next Steps
  - We engaged four volunteers, some staff at Harmony Hall, and some Society Board members to participate in this assessment.

- Recommendation is that we establish a DEI Leadership Team that would manage inquiries and other DEI support. This team will consist of one staff member and 3 volunteer project managers.
- Inclusion Ambassadors have been collected yearly since 2018 and we have well over 100 committed ambassadors that we will be able to tap into whenever projects come along.
- Our next steps are to work with SPC as we plan further actions.
